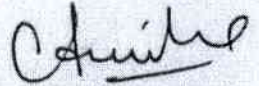

This has reference to Appeal dated 17-12-2022 filed by University College of Engineering, Kakinada, Pithapuram Road, Kakinada, East Godavari, Andhra Pradesh- 533003 against non-accreditation to the UG – Civil Engineering program of your Institution, communicated vide NBA's letter of even number dated 20.04.2022.

2. The Appeal has been considered in NBA. Representatives of the Institution also presented the case before the Appellate Committee at its meeting held on 01-03-2023. 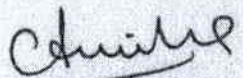
